- (1) Based on the Company's cash EPS growth as compared to the GAAP EPS growth of the S&P 500, 200% of the performance-based restricted stock unit award granted on 2/13/06 vested, resulting in an additional 6,941 shares, for a total of 13,882 shares.
- (2) 3,672 shares were withheld by the Company to satisfy the Reporting Person's tax withholding obligation upon the vesting of restricted stock units.
