ITEM 1.01 ENTRY INTO A MATERIAL DEFINITIVE AGREEMENT.

On February 2, 2009, Apogee Technology, Inc. (Apogee) received \$80,000 in proceeds from the sale of two promissory notes. TYJO Corporation Money Purchase Pension Plan loaned the company \$50,000 pursuant to the promissory note attached hereto and Herbert M. Stein loaned the company \$30,000 pursuant to the promissory note attached hereto. The promissory notes bear simple interest of 8% per year and are to be repaid in cash after 180 days.

The promissory note is attached hereto as Exhibits 99.1 and 99.2 and are incorporated herein by reference.

ITEM 2.03 CREATION OF A DIRECT FINANCIAL OBLIGATION OR AN OBLIGATION UNDER AN OFF-BALANCE SHEET ARRANGEMENT OF THE REGISTRANT.

The information required by this Item 2.03 is set forth in Item 1.01 above, which is incorporated herein by reference.

ITEM 3.02 UNREGISTERED SALES OF EQUITY SECURITIES

Associated with the promissory notes discussed above are warrants. The warrants are a three (3) year warrants with a strike price of \$1. The warrants represent 12,500 and 3,000 shares of common stock, for TYJO Corporation Money Purchase Pension Plan and for Mr. Herbert M. Stein, respectively, as added consideration for the Note. These warrants, and the warrants previously issued to TYJO Corporation Money Purchase Pension Plan and Mr. Herbert M. Stein pursuant to earlier promissory notes, have been documented using the form of warrant, Exhibit 99.3, attached.
