(1) On October 16, 2006, the Board of Directors of Chicago Mercantile Exchange Holdings Inc. (the "Company") appointed Terrence A. Duffy, the Company's current Chairman, to serve as the Executive Chairman. As an employee, Mr. Duffy will participate in the Company's equity program. On December 15, 2006, Mr. Duffy was granted a pro rata grant for 2006 of 3,475 options to purchase Class A common stock at a price of \$529.50 and 460 shares of restricted stock.

(2) These options were granted on December 15, 2006. They vest over a five-year period with 20% vesting one year after the grant date and 20% vesting on that same date in each of the following four years, subject to acceleration or termination in certain circumstances.
