- (1) Mr. Bradt contributed 15,000 shares of CNC common stock to an exchange fund in exchange for shares of the exchange fund. The CNC common stock was valued at \$58.67 per share for the purpose of determining the number of shares of the exchange fund issuable to Mr. Bradt. By factoring in the 2 for 1 stock split paid on December 17, 2004, Mr. Bradt effectively exchanged 30,000 shares of CNC common stock at \$29.34 per share for shares of the exchange fund.
- (2) Shares beneficially owned as of December 20, 2004 include shares received December 17, 2004 from a 2 for 1 stock split.
