#### Item 1. Security and Issuer.

This Amendment No. 6 to Schedule 13D on the Common Stock of American Safety Insurance Holdings LTD. (the Issuer) is being filed on behalf of the undersigned to amend the Schedule 13D, as amended (the Schedule 13D), which was originally filed on February 27, 2009 and amended on January 21, 2010, March 1, 2010, March 8, 2010, March 25, 2010 and April 12, 2010. Unless otherwise indicated, all capitalized terms used herein but not defined herein shall have the same meaning as set forth in the Schedule 13D.

#### <u>Item 2</u>. <u>Identity and Background</u>.

- (a) (c) The information previously provided in clauses (i) and (ii) in response to Item 2 is hereby updated as follows:
- (i) Argo RE, Ltd., a Bermuda class 4 insurance company (Argo RE), owns 609,749 shares of Common Stock of the Issuer; and
- (ii) Argo Group International Holdings, Ltd., a Bermuda company limited (<u>AG</u>II), may be deemed to beneficially own 609,749 shares of Common Stock of the Issuer, all of which are held by Argo RE, a wholly-owned subsidiary of AGII.

#### <u>Item 5</u>. <u>Interest in Securities of the Issuer</u>.

The information previously provided in response to Item 5 is hereby amended and supplemented as follows:

(a) The aggregate number and percentage of Common Stock of the Issuer deemed to be beneficially owned by Argo RE is 609,749 shares, which represents approximately 5.91% of the issued and outstanding Common Stock of the Issuer. The calculation of this percentage is based on 10,325,666 shares of Common Stock outstanding, as reported in the Issuer s Form 10-K filed on March 16, 2010.

The aggregate number and percentage of Common Stock of the Issuer deemed to be beneficially owned by AGII is 609,749 shares, which represents approximately 5.91% of the issued and outstanding Common Stock of the Issuer. The calculation of this percentage is based on 10,325,666 shares of Common Stock outstanding, as reported in the Issuer s Form 10-K filed on March 16, 2010.

(b) Argo RE, by virtue of its position as the holder of the 609,749 shares of Common Stock and AGII, by virtue of the fact that Argo RE is a wholly-owned subsidiary of AGII, may be deemed to have the shared power to vote and dispose of the Common Stock owned by Argo RE reported herein.

The filing of this Schedule 13D shall not be construed as an admission that any Reporting Person is, for the purposes of Section 13(d) or 13(g) of the Exchange Act, or for any other purpose, the beneficial owner of any securities other than the securities stated herein to be beneficially owned by such Reporting Person.

(c) The following transactions in the Common Stock of the Issuer were effected during the past sixty days:

On April 14, 2010, Argo RE sold 10,000 shares of Common Stock of the Issuer on the open market, at a price of \$16.27 per share.

On April 15, 2010, Argo RE sold 700 shares of Common Stock of the Issuer on the open market. The weighted average price of these shares was \$16.2743, and the range of sale prices was \$16.27 to \$16.30.

On April 16, 2010, Argo RE sold 2,400 shares of Common Stock of the Issuer on the open market, at a price of \$16.35 per share.

On April 20, 2010, Argo RE sold 22,581 shares of Common Stock of the Issuer on the open market. The weighted average price of these shares was \$16.2837, and the range of sale prices was \$16.27 to \$16.305.

On April 21, 2010, Argo RE sold 18,256 shares of Common Stock of the Issuer on the open market. The weighted average price of these shares was \$16.2925, and the range of sale prices was \$16.27 to \$16.3775.

On April 23, 2010, Argo RE sold 5,012 shares of Common Stock of the Issuer on the open market, at a price of \$16.27 per share.

On April 23, 2010, Argo RE sold 150,000 shares of Common Stock to the Issuer in a privately negotiated transaction, at a price of \$16.70 per share.

None of the persons set forth on Schedule A has effected any transactions in the Common Stock of the Issuer during the past sixty days.

- (d) No person other than the Reporting Persons is known to have the right to receive, or the power to direct the receipt of dividends from, or proceeds from the sale of, the shares of Common Stock.
