Dear Mr. McGlade:

The Airgas Board of Directors has considered the request in your July 9 letter that Airgas engage in negotiations with respect to Air Products \$63.50 offer and asked me to respond on its behalf.

Today, our Board filed an amendment to our Schedule 14D-9 unanimously rejecting the most recent Air Products offer as grossly inadequate and highly opportunistic. We continue to believe strongly that Airgas will generate more value for its stockholders by executing its strategic plan than by pursuing your company's proposed transaction. As discussed in our Schedule 14D-9 filing, recent events strengthen our belief in Airgas ability to create great value. Airgas stockholders—not Air Products—should reap the benefits of our increased earnings power and bright future.

In light of its determination that your offer is grossly inadequate and highly opportunistic, the Board believes that Air Products' offer is not a sensible starting point for any discussions or negotiations.
