We incorporate this prospectus supplement by reference into the prospectus.

This prospectus supplement relates to 253,674 shares of our common stock issued by us to one of our subsidiaries in a transaction not requiring registration under the Securities Act of 1933, as amended. Such shares were used as partial consideration to acquire all of the insurance brokerage business of the persons named under the heading Selling Stockholders.

This prospectus supplement and the related prospectus may be used to resell shares of our common stock only by the stockholders named under the heading Selling Stockholders. You should read this supplement together with the prospectus.

We are not offering or selling any securities pursuant to this prospectus supplement. We will not receive any of the proceeds from the sale of these shares by the selling stockholders.

Our common stock is traded on the New York Stock Exchange under the symbol **AJG** . Investing in our common stock involves a high degree of risk.
