ChipMOS REPORTS JANUARY 2014 REVENUE

Hsinchu, Taiwan, February 10, 2014 - ChipMOS TECHNOLOGIES (Bermuda) LTD. (ChipMOS or the Company) (NASDAQ: IMOS), an industry leading provider of outsourced semiconductor assembly and test services (OSAT), today reported its unaudited consolidated revenue for the month of January 2014.

Revenue for the month of January 2014 was NT\$1,621.7 million or US\$53.5 million, a decrease of 0.8% from the month of December 2013 and an increase of 11.6% from the same period in 2013. All U.S. figures in this release are based on the exchange rate of NT\$30.31 to US\$1.00 as of January 31, 2014.
