This Amendment No. 29 to Schedule 13D (this Amendment) relates to common shares, par value \$0.01 per share (the Holdings Common Stock), of Sears Holdings Corporation, a Delaware corporation (Holdings). This Amendment amends the Schedule 13D, as previously amended, filed with the Securities and Exchange Commission by ESL Partners, L.P., a Delaware limited partnership (Partners), SPE I Partners, LP, a Delaware limited partnership (SPE I), SPE Master I, LP, a Delaware limited partnership (SPE Master I), RBS Partners, L.P., a Delaware limited partnership (RBS), ESL Institutional Partners, L.P., a Delaware limited partnership (Institutional), RBS Investment Management, L.L.C., a Delaware limited liability company (RBSIM), CRK Partners, LLC, a Delaware limited liability company (CRK LLC), ESL Investments, Inc., a Delaware corporation (ESL), and Edward S. Lampert, a United States citizen, by furnishing the information set forth below. Except as otherwise specified in this Amendment, all previous Items are unchanged. Capitalized terms used herein which are not defined herein have the meanings given to them in the Schedule 13D, as previously amended, filed with the Securities and Exchange Commission.

### **Item 3. Source and Amount of Funds or Other Consideration.**

Item 3 is hereby amended and supplemented as follows:

Effective as of 5:00 p.m. New York City time on October 16, 2014 (the Record Date), in connection with a subscription rights offering (the Rights Offering) by Holdings to its stockholders, Holdings distributed to Partners, SPE I, SPE Master I, CRK LLC, Institutional and Mr. Lampert, at no charge, subscription rights to purchase an aggregate of 19,407,354 common shares, no par value (the Sears Canada Shares) of Sears Canada Inc., a corporation organized under the laws of Canada (Sears Canada), from Holdings. A form of the subscription rights certificate is attached hereto as Exhibit 99.10 and incorporated by reference herein.

On October 16, 2014, Partners, CRK LLC, Institutional and Mr. Lampert (the Participating Reporting Persons) exercised their subscription rights to purchase an aggregate of 17,741,508 Sears Canada Shares from Holdings for total cash consideration of \$168,544,326.00. Partners, CRK LLC and Institutional used working capital to exercise their subscription rights to purchase Sears Canada Shares. Mr. Lampert used personal funds to exercise his subscription rights to purchase Sears Canada Shares.

The Participating Reporting Persons also exercised their over-subscription privileges associated with the subscription rights to acquire, upon completion of the Rights Offering, in the aggregate up to an additional 4,538,933 Sears Canada Shares, but only to the extent that such exercise would result in the Reporting Persons owning no more than 50,438,811 Sears Canada Shares upon completion of the Rights Offering (and, in any event, less than 50.0% of the Sears Canada Shares then outstanding).

### **Item 4. Purpose of Transaction.**

Item 4 is hereby amended and supplemented as follows:

Holdings is conducting the Rights Offering, whereby Holdings distributed, at no charge, to each holder of its outstanding Holdings Common Stock as of the Record Date, transferrable subscription rights to purchase from Holdings up to an aggregate of 40,000,000 Sears Canada Shares, at a price of \$9.50 per whole share. Holdings distributed to each holder of its Holdings Common Stock one subscription right for each full share of Holdings Common Stock owned by that stockholder as of the Record Date, subject to certain exceptions. Each subscription right entitles its holder to purchase from Holdings 0.375643 of a Sears Canada Share. A form of the subscription rights certificate is attached hereto as Exhibit 99.10 and incorporated by reference herein.

Effective as of the Record Date, in connection with the Rights Offering by Holdings to its stockholders, Holdings distributed to Partners, SPE I, SPE Master I, CRK LLC, Institutional and Mr. Lampert, at no charge, subscription rights to purchase an aggregate of 19,407,354 Sears Canada Shares from Holdings. Participating Reporting Persons exercised their subscription rights to purchase an aggregate of 17,741,508 Sears Canada Shares from Holdings.

The Participating Reporting Persons also exercised their over-subscription privileges associated with the subscription rights to acquire, upon completion of the Rights Offering, in the aggregate up to an additional 4,538,933 Sears Canada Shares, but only to the extent that such exercise would result in the Reporting Persons owning no more than 50,438,811 Sears Canada Shares upon completion of the Rights Offering (and, in any event, less than 50.0% of the Sears Canada Shares outstanding).

SPE I and SPE Master I are liquidating entities and do not make new investments, such as the exercise of the subscription rights. SPE I and/or SPE Master I may sell their subscription rights in the open market and/or to certain other Reporting Persons.
