Fifth Third Bancorp (Nasdaq: FITB) announced on September 8, 2015, that Dan Poston, executive vice president and chief strategy and administrative officer, will be leaving Fifth Third and joining Vantiv, Inc. as its executive vice president, strategic client relations. Fifth Third is a significant customer of Vantiv and Mr. Poston will manage Vantiv's relationship with Fifth Third, among other duties. His last day with Fifth Third will be October 1, 2015.

On September 8, 2015, Fifth Third also announced that it has named Timothy Spence as its executive vice president and chief strategy officer. Mr. Spence will join Fifth Third on September 11, 2015. Spence will oversee all aspects of strategic planning, including mergers and acquisitions.

Mr. Spence joins Fifth Third from Oliver Wyman, an international management consulting firm where he was a senior partner in the Retail and Business Banking practice providing advice on strategy, innovation and performance improvement to executives at the world's largest financial institutions. His background also includes consulting in the wholesale banking, wealth management and payments businesses. Spence served as the firm's Midwest Market leader. Prior to joining Oliver Wyman in 2006, Spence held management positions in sales and marketing, corporate development and finance at two early-stage technology firms.
