On February 1, 2018, Dominion Energy, Inc. (Dominion) and SCANA Corporation (SCANA) issued a joint press release announcing that the Federal Trade Commission has granted early termination of the 30-day waiting period under the federal Hart-Scott-Rodino Antitrust Improvements Act with regard to the previously announced combination of Dominion Energy and SCANA. Expiration or termination of the waiting period is one of the conditions required for completion of the transaction under the Agreement and Plan of Merger among Dominion Energy, Inc., Sedona Corp. and SCANA Corporation, Inc. dated as of January 2, 2018. The press release is filed as Exhibit 99.1 hereto and is incorporated herein by reference.
