- 1,521.78 shares in the Company's ESSOP. All share amounts have been adjusted to reflect the Company's 2-for-1 stock split as of December 10, 2004.
  - Stock Options are granted on a one-for-one basis.

- In addition to the 1,904 stock options remaining in the May 16, 1997 grant, the reporting person has options to acquire 62,400 additional shares of Common Stock at varying grant prices and vesting schedules over a ten-year period. All share amounts have been adjusted to reflect the Company's 2-for-1 stock split as of December 10, 2004.
