(1) All historical share data in this Form 4 have been restated to reflect a one-for-four reverse stock split effective as of October 11, 2012.

On February 25, 2010, the reporting person received a grant of 2,250 restricted units that vest ratably on each of the first, second and third anniversaries of the date of grant. The first anniversary occurred on February 25, 2011 resulting in the vesting and settlement of 750

(2) shares of common stock. The second anniversary occurred on February 25, 2012, resulting in the vesting and settlement of 750 shares of common stock. The third anniversary of this grant occurred on February 25, 2013, resulting in the vesting and settlement of 750 shares of common stock as shown in Table I and Table II. Restricted units are settled in shares of the Company's common stock upon vesting.
