- (1) All historical share data in this Form 4 have been restated to reflect a one-for-four reverse stock split effective as of October 11, 2012. On February 29, 2012, the reporting person received a grant of 2,375 restricted units that vest ratably on each of the first, second and third anniversaries of the date of grant. The first anniversary occurred on February 28, 2013, resulting in the vesting and settlement of 792 shares of common stock, as shown in Table I. The remaining 1583 restricted units are shown in Table II, of which 792 are scheduled to vest on February 28, 2014 and 791 are scheduled to vest on February 28, 2015. Restricted units are settled in shares of the Company's common stock upon vesting.
