- (1) Restricted shares granted pursuant to the Invacare Corporation 2003 Performance Plan in an exempt transaction under Rule 16b-3. These shares vest in 25% increments over four years commencing May 15, 2014.
- (2) The share balance includes 9,861 unvested restricted shares previously granted to the reporting person and reported on a Form 4, that were inadvertently omitted from the balance reported on the reporting person's previous Form 5 filing.
- (3) No transaction is being reported on this line. Reported on a previously filed Form 3, Form 4, or Form 5.
- (4) The reporting person holds previously reported options to buy 25,142 Common Shares (with tandem tax withholding rights) under the Invacare Corporation 2003 Performance Plan, granted in reliance upon the exemption provided by Rule 16b-3. All options were granted between December 15, 2003 and August 20, 2008, at exercise prices between \$23.71 to \$47.01 per share, will expire between December 15, 2013 and August 20, 2018 and became exercisable between December 31, 2004 and September 30, 2012.
