The remaining unvested restricted stock units vest in two equal annual installments commencing on January 15, 2015. Not later than 30
- (6) days after vesting occurs, vested shares of Emcore common stock, an amount in cash equal to their fair market value or a combination of both will be delivered to the Reporting Person.
- (7) The restricted stock units were awarded to the Reporting Person for no cash or other similar consideration.
