The price in column 4 is a weighted average price. The prices actually received for the stock ranged from \$77.17 to \$77.24 per share. Mr.

On March 14, 2018, 53,712 performance-vesting restricted stock units held by Mr. Durkin vested. As the performance conditions underlying this restricted stock unit award were not achieved at the maximum level, 2,280 previously reported restricted stock units did not vest.
(2) Following the transactions reported on this Form 4, Mr. Durkin held (a) 112,329 shares of the Company's common stock and (b) 10,268 performance-vesting restricted stock units, each representing the right to receive one share of the Company's common stock.
