This Prospectus will be used from time to time by the selling shareholders named in this prospectus to resell up to an aggregate of (i) 514,527 of our voting ordinary shares, par value \$1.00 per share (the “ordinary shares”) (including up to 192,485 shares issuable upon the conversion of our Series C non-voting ordinary shares, par value \$1.00 per share (the “Series C shares”)), and (ii) 192,485 Series C shares. The selling shareholders acquired the ordinary shares and Series C shares pursuant to an Investment Agreement with Enstar Group Limited dated as of April 20, 2011. We are registering the offer and sale of the ordinary shares and the Series C shares to satisfy registration rights we have granted to the selling shareholders.

The ordinary shares and the Series C shares may be offered from time to time by the selling shareholders on any stock exchange, market or trading facility on which the shares are traded or in private transactions, at fixed or negotiated prices, through one or more methods or means as described in the section entitled “Plan of Distribution” beginning on page 4 of this prospectus. We are not selling any ordinary shares or Series C shares under this prospectus and will not receive any proceeds from the sale of our ordinary shares or Series C shares by the selling shareholders. The selling shareholders have agreed to incur all expenses in connection with this offering.

Our ordinary shares are listed on the NASDAQ Global Select Market under the symbol “ESGR.” The last reported sale price on December 15, 2016 was \$198.50 per share. The Series C shares are not listed, and we do not intend to list the Series C shares, on any exchange.

This prospectus relates to the offer and resale by the selling shareholders identified in this prospectus of up to an aggregate of (i) 514,527 of our voting ordinary shares, par value \$1.00 per share (the “ordinary shares”) (including up to 192,485 shares issuable upon the conversion of our Series C non-voting ordinary shares, par value \$1.00 per share (the “Series C shares”), and (ii) 192,485 Series C shares held by the selling shareholders named in this prospectus. We are not selling any ordinary shares or Series C shares under this prospectus and will not receive any proceeds from the sale of our ordinary shares or Series C shares by the selling shareholders. See “Use of Proceeds.”

You should carefully read the entire prospectus, including the information set forth in the section entitled “Risk Factors” and the information that is incorporated by reference into this prospectus before making your investment decision. See the sections entitled “Where You Can Find More Information” for a further discussion on incorporation by reference. Enstar Group Limited, or Enstar, is a Bermuda-based holding company that was formed in 2001 and became publicly traded in 2007. We are listed on the NASDAQ Global Select Market under the ticker symbol “ESGR.” Our principal executive offices are located at Windsor Place, 3rd Floor, 22 Queen Street, Hamilton HM JX, Bermuda, and our telephone number is (441) 292-3645.

RISK FACTORS

Investment in our securities involves risks. Before you invest in our securities, you should carefully consider the risk factors below and those incorporated into this prospectus by reference to our Annual Report on Form 10-K for the year ended December 31, 2015 and our Quarterly Report on Form 10-Q for the quarter ended September 30, 2016, and the other information contained in this prospectus, as updated by our subsequent filings under the Exchange Act, and risk factors and other information contained in any applicable prospectus supplement before acquiring any of such securities. The occurrence of any of the events described in the risk factors might cause you to lose all or part of your investment in the securities. Please also refer to the section above entitled “Cautionary Statement Regarding Forward-Looking Statements.”

Risks Relating to Ownership of our Series C Shares

It is unlikely that an active trading market for the Series C shares will develop.

The Series C shares will not be a liquid investment because no public trading market currently exists for such security and it is unlikely that such a market will develop. The Series C shares are not listed on any securities exchange, and we do not intend to list them on any such exchange. Investors seeking liquidity will generally be limited to selling their Series C shares in the secondary market or selling the underlying ordinary shares, to the extent the conversion mechanic is available. It is unlikely that an active trading market in the Series C shares will develop and, even if it develops, we cannot assure you that it will last.

Holders of the Series C shares have limited voting rights.

Holders of the Series C shares will not receive any voting rights, including the right to elect any directors, other than limited voting rights as required by Bermuda law and with respect to matters constituting a variation of class rights.

This characteristic means that the Series C shares have a limited say in the affairs of the business.

Holders of Series C shares may not be able to convert such shares into ordinary shares.

Our Series C shares automatically convert at a one-for-one exchange ratio (subject to adjustment for share splits, dividends, recapitalizations, consolidations or similar transactions) into ordinary shares if the registered holder transfers them in a widely dispersed offering, which is defined in our Bye-Laws as (i) a widespread public distribution, (ii) a transfer in which no transferee (or group of associated transferees) would receive 2% or more of any class of voting shares of the Company or (iii) a transfer to a transferee that would control more than 50% of the voting shares of the Company without any transfer from the holder. Therefore, holders do not have the ability to convert Series C shares and maintain ownership over such shares or convert Series C shares in any transfer that is not a widely dispersed offering.

USE OF PROCEEDS

We are not selling any securities under this prospectus and will not receive any proceeds from the sale of our ordinary shares or Series C shares by the selling shareholders.

SELLING SHAREHOLDERS

This prospectus relates to the possible resale by GSCP VI AIV Navi, Ltd., GSCP VI Offshore Navi, Ltd., GSCP VI Parallel AIV Navi, Ltd., GSCP VI Employee Navi, Ltd., and GSCP VI GmbH Navi, L.P., or the “selling shareholders,” of up to 514,527 ordinary shares, including up to 192,485 ordinary shares issuable upon the conversion of our Series C shares, and 192,485 Series C shares. The foregoing represent all ordinary shares and Series C shares reported to us as held by the selling shareholders as of December 9, 2016 . Pursuant to registration rights we have granted to the selling shareholders, we are registering all of these ordinary

shares and Series C shares in order to permit the selling shareholders to offer these securities for resale from time to time.

The Series C shares will automatically convert into ordinary shares upon the transfer of the Series C shares in a widely dispersed offering, which includes a widespread public distribution or a transfer in which no transferee (or group of associated transferees) would receive 2% or more of any class of our voting shares. The Series C shares will initially convert at a one-to-one ratio, subject to adjustments for share subdivisions, splits, combinations and similar events. The following table sets forth the name of each selling shareholder, the number of ordinary shares and Series C shares beneficially owned by or attributable to such selling shareholder immediately prior to this registration (which was prepared based on information supplied to us by the selling shareholders and reflects holdings as of December 9, 2016), the number of ordinary shares (including ordinary shares issuable upon the conversion of the Series C shares) and Series C shares offered hereby and registered by the registration statement of which this prospectus is a part, and the number of ordinary shares and Series C shares to be owned by each selling shareholder after this offering. The number of ordinary shares and Series C shares to be owned after this offering assumes that all ordinary shares and Series C shares covered by this prospectus will be sold by the selling shareholders and that no additional ordinary shares or Series C shares of the Company are subsequently bought or sold by the selling shareholders. However, because the selling shareholders may offer from time to time all, some or none of the ordinary shares or Series C shares covered by this prospectus, or in another permitted manner, no assurances can be given as to the actual number of ordinary shares or Series C shares that will be sold by the selling shareholders or that will be held by the selling shareholders after completion of the sales. In addition, we do not know how long the selling shareholders will hold their shares before selling them.

Sumit Rajpal, a managing director of Goldman Sachs, an affiliate of the selling shareholders was appointed to our Board of Directors in connection with the selling shareholders' investment in Enstar and served on our Board from May 2011 until his resignation in September 2016. On November 15, 2016, the selling shareholders waived and relinquished all rights they had under the Investment Agreement with Enstar Group Limited dated as of April 20, 2011 to designate a director to serve on Enstar's board of directors. As of September 30, 2016, we had investments in two funds (carried within other investments) affiliated with the selling shareholders, which had a fair value of \$15.9 million. As of September 30, 2016, we had an indirect investment in non-voting interests of two companies affiliated with Hastings Insurance Group Limited, which had a fair value of \$56.0 million. Goldman Sachs affiliates have an approximately 38% interest in the Hastings companies, and Mr. Rajpal serves as a director of the entities relating to the Hastings investment in which we have invested. For the years ended December 31, 2015 and 2014, we recognized net realized and unrealized gains of \$24.1 million and \$7.0 million, respectively, in respect of the Goldman Sachs-affiliated investments. During 2015, a Goldman Sachs affiliate began providing investment management services to one of our subsidiaries. Our interests are held in accounts managed by affiliates of Goldman Sachs, with a balance of \$790.8 million as at September 30, 2016, with respect to which we incurred approximately \$0.6 million in management fees for the year ended December 31, 2015. Fees charged pursuant to investments with affiliates of Goldman Sachs were on an arm's length basis. We also committed to invest \$25.0 million in West Street Capital Partners VII, a private equity fund managed by Goldman Sachs's Merchant Banking Division. For more information regarding our relationships with the selling shareholders, see Note 19—Related Party Transactions in our Annual Report on Form 10-K for the year ended December 31, 2015 and Note 17—Related Party Transactions in our Quarterly Report on Form 10-Q for the quarter ended September 30, 2016.

Goldman, Sachs & Co., a FINRA member, is an investment banking firm that regularly performs services such as acting as an underwriter, a financial advisor and serving as principal or underwriting or other services for market participants and may currently, in the past and/or in the future perform such services for the company. Goldman, Sachs & Co. and its affiliates that are registered broker-dealers (including specialists and market makers) may also from time to time engage in brokerage and trading activities with respect to the company's securities. In addition, Goldman, Sachs & Co. has or may have certain other business

relationships with the company, including as disclosed in the company's Annual Report on Form 10-K or proxy statement.

PLAN OF DISTRIBUTION

We are registering the ordinary shares and Series C shares on behalf of the selling shareholders to satisfy registration rights we have granted to the selling shareholders. A copy of the agreement setting forth the applicable terms and conditions of the registration of the ordinary shares and Series C shares beneficially owned by the selling shareholders is filed as an exhibit to the Registration Statement of which this prospectus is a part. We have granted the selling shareholders an additional right to request the filing of this Registration Statement in exchange for, among other things, agreeing to cover the expenses related thereto.

Additional selling shareholders not named in this prospectus may not be able to use this prospectus for resales until they are named in the selling shareholders table by prospectus supplement or post-effective amendment. Transferees, successors and donees of identified selling shareholders may not be able to use this prospectus for resales until they are named in the selling shareholders table by prospectus supplement or post-effective amendment. If required, we may add transferees, successors and donees by prospectus supplement in instances where the transferee, successor or donee has acquired its shares from holders named in this prospectus after the effective date of this prospectus. See "Selling Shareholders."

Any or all of the selling shareholders may offer the ordinary shares and Series C shares from time to time, either in increments or in a single transaction. The selling shareholders may also decide not to sell all the shares they are allowed to sell under this prospectus. The selling shareholders will act independently of us in making decisions with respect to the timing, manner and size of each sale.

The selling shareholders and any of their pledgees, donees, transferees, assignees and successors-in-interest may, from time to time, sell any or all of their ordinary shares and Series C shares on any stock exchange, market or trading facility on which the shares are traded or quoted or in private transactions. These sales may be at market prices prevailing at the time of sale, at prices related to such prevailing market prices, at fixed prices or negotiated prices.

The selling shareholders may use any one or more of the following methods when selling ordinary shares and Series C shares:

- ordinary brokerage transactions and transactions in which a broker-dealer solicits purchasers;
- block trades in which a broker-dealer will attempt to sell the shares as agent but may position and resell a portion of the block as principal to facilitate the transaction;
- purchases by a broker-dealer as principal and resale by the broker-dealer for its account;

- an exchange distribution in accordance with the rules of the applicable exchange;
- privately negotiated transactions;
- to cover short sales made after the date that this registration statement becomes effective;
- an agreement with broker-dealers to sell as agent for the selling shareholders a specified number of such shares at a stipulated price per share or otherwise at the prevailing market price;
- through put or call options, including the writing of exchange-traded call options, or other hedging transactions related to ordinary shares;
- a combination of any such methods of sale; and
- any other method permitted pursuant to applicable law.

Selling shareholders may enter into hedging transactions from time to time in which a selling shareholder may: enter into transactions with a broker-dealer or any other person in connection with which such broker-dealer or other person will engage in short sales of ordinary shares or Series C shares, in which case such broker-dealer or other person may use ordinary shares or Series C shares received from the selling shareholder to close out its short positions;

• sell ordinary shares or Series C shares short and re-deliver shares offered by this prospectus to close out its short positions or to close out stock loans incurred in connection with its short positions;

enter into option or other types of transactions that require the selling shareholder to deliver ordinary shares or Series C shares to a broker-dealer or any other person, who will then resell or transfer the ordinary shares or Series C shares under this prospectus; or

• loan or pledge the ordinary shares or Series C shares to a broker-dealer or any other person, who may sell the loaned shares or, in an event of default in the case of a pledge, sell the pledged shares under this prospectus.

The selling shareholders may also sell shares under any available exemption to the registration requirements of the Securities Act, including but not limited to Rule 144 under the Securities Act, rather than under this prospectus.

Resales by selling shareholders may be made directly to investors or through securities firms acting as underwriters, brokers or dealers. Broker-dealers engaged by the selling shareholders may arrange for other broker-dealers to participate in sales. When resales are to be made through a securities firm, the securities firm may be engaged to act as the selling shareholder's agent in the resale of the ordinary shares or Series C shares by the selling shareholder, or the securities firm may purchase ordinary shares or Series C shares from the selling shareholder as principal and thereafter resell those shares from time to time. Securities firms may, to the extent permissible, receive commissions or discounts from the selling shareholders (or, if any broker-dealer acts as agent for the purchaser of shares, from the purchaser) in amounts to be negotiated. The selling shareholders do not expect these commissions and discounts, if any, to exceed what is customary in the types of transactions involved.

The selling shareholders may from time to time pledge or grant a security interest in some or all of the ordinary shares or Series C shares owned by them and, if they default in the performance of their secured obligations, the pledgees or secured parties may offer and sell ordinary shares or Series C shares from time to time under this prospectus, or under an amendment to this prospectus or a prospectus supplement to include the pledgee, transferee or other successors in interest as selling shareholders under this prospectus.

The selling shareholders and any broker-dealers or agents that are involved in selling the shares may be deemed to be “underwriters” within the meaning of the Securities Act in connection with such sales. In such event, any commissions received by such broker-dealers or agents and any profit on the resale of the shares purchased by them may be deemed to be underwriting commissions or discounts under the Securities Act. Discounts, concessions, commissions and similar selling expenses, if any, that can be attributed to the sale of ordinary shares or Series C shares sold hereunder will be paid by the selling shareholder and/or the purchasers.

If a selling shareholder uses this prospectus for any sale of ordinary shares or Series C shares, it will be subject to the prospectus delivery requirements of the Securities Act. The selling shareholders will be responsible for complying with the applicable provisions of the Securities Act and Exchange Act, and the rules and regulations thereunder promulgated, including, without limitation, Regulation M, as applicable to such selling shareholders in connection with resales of their respective shares under this registration statement.

We have agreed to indemnify the selling shareholders and their affiliates against certain losses, claims, damages and liabilities, including liabilities under the Securities Act.

Item 15. Indemnification of Directors and Officers.

Section 98 of the Bermuda Companies Act of 1981, as amended (the “Act”), provides generally that a Bermuda company may indemnify its directors, officers and auditors against any liability that by virtue of Bermuda law otherwise would be imposed on them, except in cases where such liability arises from the fraud or dishonesty of which such director, officer or auditor may be guilty in relation to the company. Section 98 further provides that a Bermudian company may indemnify its directors, officers and auditors against any liability incurred by them in defending any proceedings, whether civil or criminal (including those involving fraud or dishonesty), in which judgment is awarded in their favor or in which they are acquitted or granted relief by the Supreme Court of Bermuda in certain proceedings arising under Section 281 of the Act. In addition, Section 98 provides that a Bermudian company may advance moneys to its directors, officers and auditors for the costs, charges and expenses incurred by them in defending any civil or criminal proceedings against them, on condition that the director, officer or auditor repay the advance if any allegation of fraud or dishonesty is proved against them.

Section 53 of our Fourth Amended and Restated Bye-laws (our “Bye-laws”) provides that all of our directors and officers will be indemnified and held harmless out of our assets from and against all losses incurred by such persons in connection with the execution of their duties as directors and officers, except that such indemnity will not extend to any matter in which such person is found, in a final judgment or decree not subject to appeal, to have committed fraud or dishonesty. In addition, our Bye-laws provide that each shareholder waives any claim, whether individually or on behalf of Enstar, against any director or officer on account of any action taken by such director or officer, or the failure of such director or officer to take any action in the performance of his duties with or for us or any of our subsidiaries, provided that such waiver shall not extend to any matter in respect of any fraud or dishonesty which may attach to such director or officer.

Our Bye-laws also provide our acknowledgment that the director designated by certain affiliates of Goldman, Sachs & Co. (“GS”) pursuant to the Investment Agreement dated April 20, 2011 between GS and Enstar may have certain rights to indemnification, advancement of expenses and/or insurance provided by GS and certain affiliates thereof. Under our Bye-laws, we have agreed that we are the indemnitor of first resort with respect to any actions, costs, charges, losses, damages or expenses incurred or sustained in connection with the execution by such director of his duties as a director of Enstar, that our duties to advance and pay expenses under our Bye-laws shall apply without regard to any rights such person may have against GS, and that we have waived and released GS from any claims for contribution, subrogation or other recovery in connection therewith. As a result, just as we would indemnify any of our other directors, we would indemnify the director affiliated with GS rather than requiring him to first pursue indemnification from other sources.

We also have entered into indemnification agreements with our directors and certain officers, which provide, among other things, that we will, to the extent permitted by applicable law, indemnify and hold harmless each indemnitee if, by reason of such indemnitee's status as one of our directors or officers, such indemnitee was, is or is threatened to be made a party or participant in any threatened, pending or completed proceeding, whether of a civil, criminal, administrative, regulatory or investigative nature, against all judgments, penalties, fines, excise taxes, interest and amounts paid in settlement and incurred by such indemnitee in connection with such proceeding. In addition, each indemnification agreement provides for the advancement of expenses incurred by the indemnitee in connection with any proceeding covered by the agreement, subject to certain exceptions. None of the indemnification agreements precludes any other rights to indemnification or advancement of expenses to which the indemnitee may be entitled, including but not limited to, any rights arising under our governing documents, or any other agreement, any vote of our shareholders or any applicable law.

We have entered into employment agreements with our four executive officers that each contain provisions requiring us to indemnify and defend these executive officers to the fullest extent permitted by law and under our governing documents.

We have purchased insurance on behalf of our directors and officers for liabilities arising out their capacities as such. Item 16. Exhibits.
