Item 2.06 Material Impairments.

On September 22, 2017, Transocean Ltd. (the "Company") announced that it intends to dispose of, in an environmentally responsible way, the following six rigs: the five ultra-deepwater floaters GSF Jack Ryan, Sedco Energy, Sedco Express, Cajun Express and Deepwater Pathfinder and the deepwater floater Transocean Marianas. These rigs are classified as held for sale. As a result of the Company's decision to dispose of these six rigs on September 21, 2017, the Company concluded that it expects its third quarter 2017 results to include an estimated non-cash charge of approximately \$1.4 billion. As the Company continues to evaluate the long-term competitiveness of its fleet, additional rigs may be identified as candidates for disposal.
