- (1) The option vests and becomes exercisable as to 25% of the option shares annually beginning October 1, 2019.
- (2) Each restricted stock unit (RSU) represents a contingent right to receive one share of common stock.  
The RSU shares vest based upon a vesting price equal to the volume weighted average trading price of our common stock over sixty-five consecutive trading days. The RSU shares vest as to (i) 25,000 shares if the vesting price equals or exceeds \$5.00 per share, (ii) 75,000 shares if the vesting price equals or exceeds \$10.00 per share and (iii) 150,000 shares on the later of (a) October 1, 2019 and (b) the date the vesting price equals or exceeds \$15.00 per share. The shares covered by the RSU would be issued following vesting as provided in the 2014 Equity Incentive Plan and RSU agreement
