The Company encourages investors and other users of these financial statements to review its financial statements and other publicly-filed reports in their entirety and not to rely on any single financial measure. A reconciliation of reported income from operations before restructuring to income from operations is included in the Company's press release attached hereto as Exhibit 99.1.
