Halliburton Company (the Company or Halliburton) has conducted a reasonable country of origin inquiry (RCOI), as described herein, of its suppliers to determine whether any conflict minerals, as defined by paragraph (d)(3) of Item 1.01 of Form SD, necessary to the functionality or production of a product manufactured or contracted to be manufactured by the Company during 2013 (the Products) originated from the Democratic Republic of the Congo or an adjoining country. Following Halliburton's RCOI, and after exercising appropriate due diligence, Halliburton has been unable to determine whether any of the Products are DRC conflict-free as defined by paragraph (d)(4) of Item 1.01 of Form SD. Accordingly, Halliburton has determined that the Products are "DRC conflict undeterminable," as defined by paragraph (d)(5) of Item 1.01 of Form SD.
