- (1) Shares purchased through regularly scheduled salary deferrals through the Bar Harbor Bankshares 401(k) Plan f/b/o Cheryl D. Curtis.
 Grant of Incentive Stock Options to acquire 3,000 shares of Bar Harbor Bankshares common stock under the Bar Harbor Bankshares (and subsidiaries) Incentive Stock Option Plan of 2000. Options become exercisable with respect to 444 shares on 2/22/2006 and 6 annual increments of 426 shares beginning 2/22/2007 at an option price of \$27.75 per share. These options expire on 2/22/2015.
- (3) Grant of Incentive Stock Options to acquire 7,000 shares of Bar Harbor Bankshares common stock under the Bar Harbor Bankshares (and subsidiaries) Incentive Stock Option Plan of 2000. Options become exercisable with respect to 1,000 shares on 10/18/2006 and in 6 annual increments of 1,000 shares starting on 10/18/2007. These options are at a price of \$26.99 per share and expire on 10/18/2015.
