## **TEVA ANNOUNCES FINAL APPROVAL OF MELOXICAM TABLETS**

Jerusalem, Israel, July 20, 2006 - Teva Pharmaceutical Industries Ltd. (Nasdaq: TEVA) announced today that the U. S. Food and Drug Administration has granted approval for the Company's Abbreviated New Drug Application ("ANDA") for Meloxicam Tablets, 7.5 mg and 15 mg. Shipment of this product will begin immediately.

Teva's Meloxicam Tablets is the AB-rated generic equivalent of Boehringer Ingelheim Pharmaceuticals, inc.'s Mobic<sup>®</sup> Tablets. This product is indicated for the relief of the signs and symptoms of osteoarthritis and rheumatoid arthritis.

Annual brand product sales in the U.S. were approximately \$1 billion for the twelve months ended March 2006, based on IMS data.

Teva Pharmaceutical Industries Ltd., headquartered in Israel, is among the top 20 pharmaceutical companies in the world and is the leading generic pharmaceutical company. The company develops, manufactures and markets generic and innovative human pharmaceuticals and active pharmaceutical ingredients, as well as animal health pharmaceutical products. Over 80% of Teva's sales are in North America and Europe.
