- (1) The shares of deferred stock are fully vested on the date of grant and will be settled in shares of Manpower common stock on a 1 for 1 basis within 30 days after the reporting person's termination of service as a director.
- (2) Receipt of deferred stock under the 2003 Equity Incentive Plan of Manpower Inc. (the "Plan") and the Terms and Conditions Regarding the Grant of Awards to Non-Employee Directors under the Plan (the "Terms and Conditions") in lieu of dividends.
- (3) Represents the Average Trading Price (as defined in the Terms and Conditions).
- (4) The shares of deferred stock will vest in quarterly installments on the last day of each calendar quarter during 2007 and will be settled in shares of Manpower common stock on a 1 for 1 basis on the earlier of January 1, 2010 or within 30 days after the reporting person's termination of service as a director, except as provided in the Terms and Conditions (Amended and Restated January 1, 2006).
- (5) Annual grant of deferred stock under the Plan and the Terms and Conditions (Amended and Restated Effective January 1, 2006).
- (6) Represents the Market Price (as defined in the Plan) on the last trading day of 2006.
