Pursuant to an investment management agreement, Sigma Management maintains investment and voting power with respect to the securities held by Sigma Capital Associates. Mr. Cohen controls each of CR Intrinsic Investors and Sigma Management. By reason of the provisions of Rule 13d-3 of the Securities Exchange Act of 1934, as amended, each of (i) CR Intrinsic Investors and Mr. Cohen may be deemed to own beneficially 500,000 Shares (constituting approximately 2.0% Shares outstanding) and (ii) Sigma Management and Mr. Cohen may be deemed to own beneficially 775,000 Shares (constituting approximately 3.1% Shares outstanding). Each of CR Intrinsic Investors, Sigma Management and Mr. Cohen disclaim beneficial

ownership of any of the securities covered by this statement.
