(1) The disposition of shares occurred pursuant to the Exchange Agreement, dated December 14, 2018, between the Issuer, Wells Fargo Bank, National Association ("WFBNA") and Wells Fargo Municipal Capital Strategies, LLC ("Capital Strategies") pursuant to which (i) WFBNA exchanged 879 existing Variable Rate MuniFund Term Preferred Shares, Series 2019 ("VMTP Shares") of the Issuer for an equal number of newly issued Adjustable Rate MuniFund Term Preferred Shares, Series 2028 ("AMTP Shares") of the Issuer in a cashless exchange and (ii) Capital Strategies exchanged 851 VMTP Shares, Series 2019, of the Issuer for an equal number of newly issued AMTP Shares, Series 2028, of the Issuer in a cashless exchange.

(2) This statement is jointly filed by Wells Fargo & Company ("Wells Fargo"), Capital Strategies and WFBNA. Wells Fargo holds an indirect interest in the securities listed in Table I (the "Securities") by virtue of its indirect ownership of its subsidiary Capital Strategies and WFBNA. Capital Strategies and WFBNA are each indirect wholly owned subsidiaries of Wells Fargo.
