Autocallable Securities Based on the Worst Performing of the S&P 500<sup>®</sup> Index, the Russell 2000<sup>®</sup> Index and the Dow Jones Industrial Average<sup>™</sup> Due April 11, 2022

The securities offered by this pricing supplement are unsecured senior debt securities issued by Citigroup Global Markets Holdings Inc. and guaranteed by Citigroup Inc. Unlike conventional debt securities, the securities do not pay interest, do not guarantee the repayment of principal at maturity and are subject to potential automatic early redemption on an annual basis on the terms described below. Your return on the securities will depend on the **worst performing** of the S&P 500<sup>®</sup> Index, the Russell 2000<sup>®</sup> Index and the Dow Jones Industrial Average<sup>™</sup> (each, an “underlying index”).

The securities provide for the repayment of principal *plus* an upside premium following the first valuation date on which the closing level of the worst performing underlying index is greater than or equal to its initial index level. If the closing level of the worst performing underlying index is not greater than or equal to its initial index level on any of the valuation dates, the securities will not be repaid at the upside premium and, instead, you will receive a payment at maturity that will depend on the closing level of the worst performing underlying index on the final valuation date. If the closing level of the worst performing underlying index on the final valuation date is less than its initial index level but greater than or equal to its trigger level, you will be repaid your stated principal amount and will receive the contingent downside premium specified below. **However, if the closing level of the worst performing underlying index on the final valuation date is less than 70% of its initial index level, you will lose at least 30%, and possibly significantly more, of your investment in the securities.** Your return on the securities will depend solely on the performance of the worst performing underlying index, and you will not benefit in any way from the performance of any better performing underlying index.

If we and Citigroup Inc. default on our obligations, you may not receive any amount owed to you under the securities. **All payments on the securities are subject to the credit risk of Citigroup Global Markets Holdings Inc. and Citigroup Inc.**

For example, certain events may occur that could affect your return on the securities. These events, including market disruption events and other events affecting the underlying indices, and their consequences are described in the accompanying product supplement in the sections “Description of the Securities—Certain Additional Terms for Securities Linked to an Underlying Index—Consequences of a Market Disruption Event; Postponement of a Valuation Date” and “—Discontinuance or Material Modification of an Underlying Index,” and not in this pricing supplement. The accompanying underlying supplement contains important disclosures regarding each underlying index that are not repeated in this pricing supplement. It is important that you read the accompanying product supplement, underlying supplement, prospectus supplement and prospectus together with this pricing supplement in connection with your investment in the securities. Certain terms used but not defined in this pricing supplement are defined in the accompanying product supplement.

## Hypothetical Examples

The diagram below illustrates the payment you may receive at maturity of the securities, assuming the securities have not previously been redeemed, for a range of hypothetical percentage changes in the closing level of the worst performing underlying index from the pricing date to the final valuation date. Your payment at maturity will be determined solely based on the performance of the worst performing underlying index, regardless of the performance of the other underlying indices, as measured on the final valuation date.

**Investors in the securities will not receive any dividends on the stocks that constitute the underlying indices. The diagram and examples below do not show any effect of lost dividend yield over the term of the securities.** See “Summary Risk Factors—Investing in the securities is not equivalent to investing in the underlying indices or the stocks that constitute the underlying indices” below.

### Payment at Maturity

The following table illustrates how the amount payable per security will be calculated if the closing level of the worst performing underlying index is greater than or equal to its initial index level on one of the four valuation dates. Figures below have been rounded for ease of analysis.

April 6, 2022	\$1,000 + applicable upside premium = \$1,000 + \$520.00 = \$1,520.00

**If, on any valuation date, the closing levels of two underlying indices are greater than or equal to their respective initial index levels but the closing level of the other underlying index is less than its initial index level, you will not receive the upside premium indicated above following that valuation date. In order to receive the upside premium indicated above, the closing level of *each* underlying index must be greater than or equal to its initial index level on the applicable valuation date.**

The examples below illustrate how the payment at maturity will be calculated if the closing level of the worst performing underlying index is **not** greater than or equal to its initial index level on any of the valuation dates. The examples are based on (i) with reference to the S&P 500<sup>®</sup> Index, an initial index level of 2,640.87 and a trigger level of 1,848.609, (ii) with reference to the Russell 2000<sup>®</sup> Index, an initial index level of 1,529.427 and a trigger level of 1,070.599 and (iii) with reference to the Dow Jones Industrial Average<sup>™</sup>, an initial index level of 24,103.11 and a trigger level of 16,872.177, and in each case the hypothetical closing levels on the final valuation date indicated below. If the securities are not automatically redeemed prior to maturity, your actual payment at maturity will depend on the actual closing level of the worst performing underlying index on the final valuation date.

**Example 1.** On the final valuation date, the hypothetical closing level of the S&P 500<sup>®</sup> Index is 2,244.74 (a 15% decrease from its initial index level), the hypothetical closing level of the Russell 2000<sup>®</sup> Index is 1,682.369 (a 10% increase from its initial index level) and the hypothetical closing level of the Dow Jones Industrial Average<sup>™</sup> is 25,308.27 (a 5% increase from its initial index level). The worst performing underlying index is the underlying index with the lowest underlying index performance factor, which is calculated for each underlying index as follows:

$$\begin{aligned} \text{Underlying index performance factor of the S\&P 500}^{\text{®}} \text{ Index} &= \frac{\text{closing level on final valuation date}}{\text{initial index level}} \\ &= 2,244.74 / 2,640.87 \\ &= 0.85 \end{aligned}$$

$$\begin{aligned} \text{Underlying index performance factor of the Russell 2000}^{\text{®}} \text{ Index} &= \frac{\text{closing level on final valuation date}}{\text{initial index level}} \\ &= 1,682.370 / 1,529.427 \\ &= 1.10 \end{aligned}$$

$$\begin{aligned} \text{Underlying index performance factor of the Dow Jones Industrial Average}^{\text{™}} &= \frac{\text{closing level on final valuation date}}{\text{initial index level}} \\ &= 25,308.27 / 24,103.11 \\ &= 1.05 \end{aligned}$$

Because the underlying index performance factor of the S&P 500<sup>®</sup> Index is lower than the underlying index performance factors of the Russell 2000<sup>®</sup> Index and the Dow Jones Industrial Average<sup>™</sup> in this example, the S&P 500<sup>®</sup> Index would be the worst performing underlying index. In this scenario, because the closing level of the worst



performing underlying index on the final valuation date is less than its initial index level but greater than its trigger level, you would be paid the stated principal amount of \$1,000 *plus* the contingent downside premium at maturity, for a total payment at maturity of \$1,100 per security.

**Example 2.** On the final valuation date, the hypothetical closing level of the S&P 500® Index is 2,772.91 (a 5% increase from its initial index level), the hypothetical closing level of the Russell 2000® Index is 1,147.070 (a 25% decrease from its initial index level) and the hypothetical closing level of the Dow Jones Industrial Average™ is 9,641.24 (a 60% decrease from its initial index level). The worst performing underlying index is the underlying index with the lowest underlying index performance factor, which is calculated for each underlying index as follows:

$$\begin{aligned} \text{Underlying index performance factor of the S\&P 500}^{\circledR} \text{ Index} &= \frac{\text{closing level on final valuation date}}{\text{initial index level}} \\ &= 2,772.91 / 2,640.87 \\ &= 1.05 \end{aligned}$$

$$\begin{aligned} \text{Underlying index performance factor of the Russell 2000}^{\circledR} \text{ Index} &= \frac{\text{closing level on final valuation date}}{\text{initial index level}} \\ &= 1,147.070 / 1,529.427 \\ &= 0.75 \end{aligned}$$

$$\begin{aligned} \text{Underlying index performance factor of the Dow Jones Industrial Average}^{\text{TM}} &= \frac{\text{closing level on final valuation date}}{\text{initial index level}} \\ &= 9,641.24 / 24,103.11 \\ &= 0.40 \end{aligned}$$

Because the underlying index performance factor of the Dow Jones Industrial Average™ is lower than the underlying index performance factors of the S&P 500® Index and the Russell 2000® Index in this example, the Dow Jones Industrial Average™ would be the worst performing underlying index. In this scenario, because the closing level of the worst performing underlying index on the final valuation date is less than its trigger level, the payment at maturity per security would be calculated as follows:

$$\begin{aligned} \text{Payment at maturity per security} &= \$1,000 \times \text{the underlying index performance factor of the worst performing underlying index on the final valuation date} \\ &= \$1,000 \times 0.40 \\ &= \$400 \end{aligned}$$

In this scenario, the worst performing underlying index has depreciated by more than 30% from its initial index level to its closing level on the final valuation date, which is less than the applicable trigger level. Accordingly, your payment at maturity in this scenario would reflect 1-to-1 downside exposure to the depreciation of the worst performing underlying index from its initial index level to its closing level on the final valuation date, and you would incur a significant loss on your investment.

#### Summary Risk Factors

An investment in the securities is significantly riskier than an investment in conventional debt securities. The securities are subject to all of the risks associated with an investment in our conventional debt securities (guaranteed by Citigroup Inc.), including the risk that we and Citigroup Inc. may default on our obligations under the securities, and are also subject to risks associated with each of the underlying indices. Accordingly, the securities are suitable only for investors who are capable of understanding the complexities and risks of the securities. You should consult your own financial, tax and legal advisors as to the risks of an investment in the securities and the suitability of the securities in light of your particular circumstances.

The following is a summary of certain key risk factors for investors in the securities. You should read this summary together with the more detailed description of risks relating to an investment in the securities contained in the section “Risk Factors Relating to the Securities” beginning on page EA-6 in the accompanying product supplement. You should also carefully read the risk factors included in the accompanying prospectus supplement and in the documents incorporated by reference in the accompanying prospectus, including Citigroup Inc.’s most recent Annual Report on Form 10-K and any subsequent Quarterly Reports on Form 10-Q, which describe risks relating to the business of Citigroup Inc. more generally.

**§ You may lose some or all of your investment.** Unlike conventional debt securities, the securities do not guarantee repayment of the stated principal amount at maturity. If the securities are not automatically redeemed prior to maturity, your payment at maturity will depend on the performance of the worst performing underlying index on the final valuation date. If the closing level of the worst performing underlying index on the final valuation date is less than its trigger level, you will lose 1% of the stated principal amount of the securities for every 1% by which the

worst performing underlying index on the final valuation date has declined from its initial index level, regardless of the performance of the other underlying indices. There is no minimum payment at maturity on the securities, and you may lose your entire investment in the securities.

**The trigger feature of the securities exposes you to particular risks.** If the closing level of the worst performing underlying index on the final valuation date is less than its trigger level, you will lose 1% of the stated principal amount of the securities for every 1% by which the worst performing underlying index has declined from its initial index level. Although you will be repaid your stated principal amount and will receive the contingent downside premium at maturity if the worst performing underlying index on the final valuation date depreciates by 30% or less from its initial index level, you will have full downside exposure to the worst performing underlying index on the final valuation date if it depreciates by more than 30%. As a result, you may lose your entire investment in the securities.

**The securities do not pay interest.** You should not invest in the securities if you seek current income during the term of the securities.

**Your potential return on the securities is limited.** Your potential return on the securities is limited to the upside premium payable upon automatic early redemption or at maturity, as described on the cover page of this pricing supplement, or in certain circumstances the contingent downside premium. If the closing level of the worst performing underlying index on one of the valuation dates is greater than or equal to its initial index level, you will be repaid the stated principal amount of your securities and will receive the fixed upside premium applicable to that valuation date, regardless of how significantly the closing level of the worst performing underlying index on that valuation date may exceed its initial index level. Accordingly, the upside premium may result in a return on the securities that is significantly less than the return you could have achieved on a direct investment in any or all of the underlying indices. In addition, the upside premium you receive upon any early redemption of the securities may be significantly less than the return you could have achieved if the securities had not been automatically redeemed and you had been able to receive the payment at maturity.

**The securities are subject to the risks of each of the underlying indices and will be negatively affected if any underlying index performs poorly, even if the others perform well.** You are subject to risks associated with each of the underlying indices. If any of the underlying indices performs poorly, you will be negatively affected, even if the other underlying indices perform well. The securities are not linked to a basket composed of the underlying indices, where the better performance of two could ameliorate the poor performance of the other. Instead, you are subject to the full risks of whichever of the underlying indices is the worst performing underlying index.

**You will not benefit in any way from the performance of the better performing underlying indices.** The return on the securities depends solely on the performance of the worst performing underlying index, and you will not benefit in any way from the

performance of the better performing underlying indices. The securities may underperform a similar investment in each of the underlying indices or a similar alternative investment linked to a basket composed of the underlying indices, since in either such case the performance of the better performing underlying indices would be blended with the performance of the worst performing underlying index, resulting in a better return than the return of the worst performing underlying index.

**The term of the securities may be as short as one year.** If the closing level of the worst performing underlying index on any valuation date, including the valuation date expected to occur approximately one year after the pricing date, is greater than or equal to its initial index level, the securities will be automatically redeemed. The earlier the automatic redemption, the lower the upside premium you will receive.

**You will be subject to risks relating to the relationship among the underlying indices.** It is preferable from your perspective for the underlying indices to be correlated with each other, in the sense that they tend to increase or decrease at similar times and by similar magnitudes. By investing in the securities, you assume the risk that the underlying indices will not exhibit this relationship. The less correlated the underlying indices, the more likely it is that any one of the underlying indices will perform poorly over the term of the securities. All that is necessary for the securities to perform poorly is for one of the underlying indices to perform poorly; the performance of the underlying indices that are not the worst performing underlying index is not relevant to your return on the securities at maturity or on an earlier automatic redemption date. It is impossible to predict what the relationship among the underlying indices will be over the term of the securities. **The S&P 500<sup>®</sup> Index represents large capitalization stocks in the United States, the Russell 2000<sup>®</sup> Index represents small capitalization stocks in the United States and the Dow Jones Industrial Average<sup>™</sup> represents 30 selected blue chip stocks in the United States. Accordingly, the underlying indices represent markets that differ in significant ways and, therefore, may not be correlated with each other.**

**Investing in the securities is not equivalent to investing in the underlying indices or the stocks that constitute the underlying indices.** You will not have voting rights, rights to receive any dividends or other distributions or any other rights with respect to any of the stocks that constitute the underlying indices. It is important to understand that, for purposes of measuring the performance of the underlying indices, the levels used will not reflect the receipt or reinvestment of dividends or distributions on the stocks that constitute the underlying indices. Dividend or distribution yield on the stocks that constitute the underlying indices would be expected to represent a significant portion of the overall return on a direct investment in the stocks that constitute the underlying indices, but will not be reflected in the performance of the underlying indices as measured for purposes of the securities (except to the extent that dividends and distributions reduce the levels of the underlying indices). Moreover, unlike a direct investment in the underlying indices, the appreciation potential of the securities is limited, as described above.

**§ Your return on the securities depends on the closing levels of the underlying indices on only four days.**

Because your payment upon automatic early redemption, if applicable, or at maturity depends on the closing levels of the underlying indices solely on one of the four valuation dates, you are subject to the risk that the closing levels of the underlying indices on those days may be lower, and possibly significantly lower, than on one or more other dates during the term of the securities. If you had invested in another instrument linked to the underlying indices that

you could sell for full value at a time selected by you, or if the return on the securities was based on an average of closing levels of the underlying indices, you might have achieved better returns.

We determine our internal funding rate based on factors such as the costs associated with the securities, which are generally higher than the costs associated with conventional debt securities, and our liquidity needs and preferences. ## United States Federal Tax Considerations

In the opinion of our counsel, Davis Polk & Wardwell LLP, which is based on current market conditions, a security should be treated as a prepaid forward contract for U.S. federal income tax purposes. By purchasing a security, you agree (in the absence of an administrative determination or judicial ruling to the contrary) to this treatment. There is uncertainty regarding this treatment, and the IRS or a court might not agree with it.

Assuming this treatment of the securities is respected and subject to the discussion in “United States Federal Tax Considerations” in the accompanying product supplement, the following U.S. federal income tax consequences should result under current law:

You should not recognize taxable income over the term of the securities prior to maturity, other than pursuant to a sale or exchange.

Upon a sale or exchange of a security (including retirement at maturity), you should recognize capital gain or loss equal to the difference between the amount realized and your tax basis in the security. Such gain or loss should be long-term capital gain or loss if you held the security for more than one year.

The notice focuses in particular on whether to require holders of these instruments to accrue income over the term of their investment. It also asks for comments on a number of related topics, including the character of income or loss with respect to these instruments; whether short-term instruments should be subject to any such accrual regime; the relevance of factors such as the exchange-traded status of the instruments and the nature of the underlying property to which the instruments are

linked; the degree, if any, to which income (including any mandated accruals) realized by non-U.S. investors should be subject to withholding tax; and whether these instruments are or should be subject to the “constructive ownership” regime, which very generally can operate to recharacterize certain long-term capital gain as ordinary income and impose an interest charge. While the notice requests comments on appropriate transition rules and effective dates, any Treasury regulations or other guidance promulgated after consideration of these issues could materially and adversely affect the tax consequences of an investment in the securities, including the character and timing of income or loss and the degree, if any, to which income realized by non-U.S. persons should be subject to withholding tax, possibly with retroactive effect.

**Possible Withholding Under Section 871(m) of the Code.** As discussed under “United States Federal Tax Considerations—Tax Consequences to Non-U.S. Holders” in the accompanying product supplement, Section 871(m) of the Code and Treasury regulations promulgated thereunder (“Section 871(m)”) generally impose a 30% withholding tax on dividend equivalents paid or deemed paid to Non-U.S. Holders with respect to certain financial instruments linked to U.S. equities (“U.S. Underlying Equities”) or indices that include U.S. Underlying Equities. Section 871(m) generally applies to instruments that substantially replicate the economic performance of one or more U.S. Underlying Equities, as determined based on tests set forth in the applicable Treasury regulations (a “Specified Security”). However, the regulations, as modified by an IRS notice, exempt financial instruments issued in 2018 that do not have a “delta” of one. Based on the terms of the securities and representations provided by us, our counsel is of the opinion that the securities should not be treated as transactions that have a “delta” of one within the meaning of the regulations with respect to any U.S. Underlying Equity and, therefore, should not be Specified Securities subject to withholding tax under Section 871(m).

A determination that the securities are not subject to Section 871(m) is not binding on the IRS, and the IRS may disagree with this treatment. Moreover, Section 871(m) is complex and its application may depend on your particular circumstances. For example, if you enter into other transactions relating to a U.S. Underlying Equity, you could be subject to withholding tax or income tax liability under Section 871(m) even if the securities are not Specified Securities subject to Section 871(m) as a general matter. You should consult your tax adviser regarding the potential application of Section 871(m) to the securities.

If withholding tax applies to the securities, we will not be required to pay any additional amounts with respect to amounts withheld.

### Supplemental Plan of Distribution

CGMI, an affiliate of Citigroup Global Markets Holdings Inc., is the underwriter of the sale of the securities. CGMI will not receive any underwriting fee in connection with the offering of the securities. However, CGMI and its affiliates may profit from expected hedging activity related to this offering. From these expected hedging profits, CGMI will pay selected dealers participating in the distribution of the securities a structuring fee of \$4.00 for each security sold in this offering.

CGMI is an affiliate of ours. Accordingly, this offering will conform with the requirements addressing conflicts of interest when distributing the securities of an affiliate set forth in Rule 5121 of the Financial Industry Regulatory Authority. Client accounts over which Citigroup Inc. or its subsidiaries have investment discretion will not be permitted to purchase the securities, either directly or indirectly, without the prior written consent of the client.

Secondary market sales of securities typically settle two business days after the date on which the parties agree to the sale. Because the issue date for the securities is more than two business days after the pricing date, investors who wish to sell the securities at any time prior to the second business day preceding the issue date will be required to specify an alternative settlement date for the secondary market sale to prevent a failed settlement. Investors should consult their own investment advisors in this regard.

A portion of the net proceeds from the sale of the securities will be used to hedge our obligations under the securities. ### Valuation of the Securities

CGMI calculated the estimated value of the securities set forth on the cover page of this pricing supplement based on proprietary pricing models. CGMI's proprietary pricing models generated an estimated value for the securities by estimating the value of a hypothetical package of financial instruments that would replicate the payout on the securities, which consists of a fixed-income bond (the "bond component") and one or more derivative instruments underlying the economic terms of the securities (the "derivative component"). CGMI calculated the estimated value of the bond component using a discount rate based on our internal funding rate. CGMI calculated the estimated value of the derivative component based on a proprietary derivative-pricing model, which generated a theoretical price for the instruments that constitute the derivative component based on various inputs, including the factors described under "Summary Risk Factors—The value of the securities prior to maturity will fluctuate based on many unpredictable factors" in this pricing supplement, but not including our or Citigroup Inc.'s creditworthiness. These inputs may be market-observable or may be based on assumptions made by CGMI in its discretionary judgment.

For a period of approximately three months following issuance of the securities, the price, if any, at which CGMI would be willing to buy the securities from investors, and the value that will be indicated for the securities on any brokerage account statements prepared by CGMI or its affiliates (which value CGMI may also publish through one or more financial information vendors), will reflect a temporary upward adjustment from the price or value that would otherwise be determined. This temporary upward adjustment represents a portion of the hedging profit expected to be realized by CGMI or its affiliates over the term of the securities.
