**Upside participation rate:** 200%

**Maximum return at maturity:** The maximum return at maturity will be determined on the pricing date and will be at least \$252.50 per security (25.25% of the stated principal amount). The payment at maturity per security will not exceed the stated principal amount *plus* the maximum return at maturity.

**Buffer amount:** 10%

You will receive at maturity for each security you then hold:

If the final underlying value is **greater than or equal to** the initial underlying value:

$\$1,000 +$  the return amount, subject to the maximum return at maturity

If the final underlying value is **less than** the initial underlying value by an amount **less than or equal to** the buffer amount:

$\$1,000$

**Payment at Maturity:**

If the final underlying value is **less than** the initial underlying value by an amount **greater than** the buffer amount:

$\$1,000 + [\$1,000 \times (\text{the underlying return} + \text{the buffer amount})]$
