- (1) On November 3, 2013, 15,300 restricted shares of Mr. Pierson's previously-granted Company stock vested. On November 4, 2013, Mr. Pierson automatically surrendered 4,874 of the 15,300 newly-vested shares to the Company to satisfy the tax withholding obligation triggered upon the November 3rd vesting. The automatic surrender of newly-vested shares is the Company's default process for paying tax withholding obligations triggered upon the vesting of restricted stock.
- (2) On November 3, 2013, 1,220 restricted shares of Mr. Pierson's previously-granted Company stock vested. On November 4, 2013, Mr. Pierson automatically surrendered 389 of the 1,220 newly-vested shares to the Company to satisfy the tax withholding obligation triggered upon the November 3rd vesting. The automatic surrender of newly-vested shares is the Company's default process for paying tax withholding obligations triggered upon the vesting of restricted stock.
