- (1) Restricted stock units convert into common stock on a one-for-one basis. Accordingly, there was no purchase price paid by the reporting person.
- (2) On September 15, 2016, 4,615 shares of United Natural Foods, Inc. (the "Company") restricted stock units vested. The Company retained 1,735 shares on that date to satisfy certain tax withholding obligations in connection with the vesting.
