On December 4, 2012, the reporting person exercised part of these options to purchase 2,500 shares of Class A Common Stock.

  - (9) This option was granted on December 1, 2017 as an option for 5,000 shares of Class A Common Stock at an exercise price of \$5.05 per share, but adjusted pursuant to the anti-dilution provisions of the 2013 Stock Option Plan to reflect a 5% stock dividend paid on February 2, 2018.
