**Merger of Nine MTS Subsidiaries Completed**

**Moscow, Russian Federation April 4, 2006 Mobile TeleSystems OJSC ( MTS - NYSE: MBT), the largest mobile phone operator in Russia and the CIS, announces the completion of the merger of nine subsidiaries into MTS.**

In line with MTS' strategy to improve the Group's efficiency, the Company has completed the merger of nine of its 100%-owned subsidiaries in Russia. The following subsidiaries were merged into MTS: Gorizont RT, TAIF-TELKOM, MTS-RTK, Sibchallenge, Tomsk Cellular Communications ( TSS ), BM Telecom, Far East Cellular Systems-900 ( FECS-900 ), Siberia Cellular Systems-900 ( SCS-900 ) and Uraltel.

The merger process was approved by the Extraordinary General Meeting on February 22, 2006 and by the Russian registration authority on March 31, 2006.
