Item 1. Security and Issuer.

This Amendment No. 12 to Schedule 13D (the Statement) relates to the Common Stock, no par value per share (the Common Stock), of Winmark Corporation, a Minnesota corporation (the Company). Depending on the same factors, the Reporting Person may decide in the future to sell all or part of his investments in the Issuer s Common Stock.
