Item 1.01 Entry into a Material Definitive Agreement.

On July 19, 2012, AdCare Property Holdings, LLC (AdCare Holdings), a wholly owned subsidiary of AdCare Health Systems, Inc., entered into an Amendment to Purchase Agreement (the Amendment) with 1761 Pinewood Holdings, LLC (Pinewood), which amends that certain Purchase Agreement, dated April 27, 2012 (the Purchase Agreement), between AdCare Holdings and Pinewood pursuant to which AdCare Holdings may acquire from Pinewood certain land, buildings, improvements, furniture, fixtures, operating agreements and equipment comprising the Sumter Valley Nursing and Rehab Center, a 96-bed skilled nursing facility located in Sumter, South Carolina, for an aggregate purchase price of \$5,500,000, subject to the terms and conditions of the Purchase Agreement (the Sumter Valley Purchase).

The Amendment: (i) extends the closing date of the Sumter Valley Purchase to August 31, 2012; (ii) requires AdCare Holdings to deliver an additional \$150,000 to Pinewood to be held as earnest money; and (iii) provides that all amounts held as earnest money under the Purchase Agreement (including, but not limited to, the \$150,000 deposited by AdCare Holdings pursuant to the Amendment) shall be credited against the purchase price at closing (or returned to AdCare Holdings in the event of a default by Pinewood as specified in the Purchase Agreement).
