ITEM 5.07. SUBMISSION OF MATTERS TO A VOTE OF SECURITY HOLDERS

On April 26, 2013, Information Services Group, Inc. (ISG or the Company) held its Annual Meeting of Stockholders. Of the 36,586,754 shares outstanding and entitled to vote, 25,679,435 shares were represented at the meeting in person or by proxy, or an approximately 70.2% quorum. The final results of voting for each matter submitted to a vote of stockholders at the meeting are as follows:

Proposal 1: Election of Directors. The following directors were elected to hold office until the 2016 Annual Meeting of Stockholders and until their successors have been elected and have qualified to hold such office. The results of the election for each director are as follows:
