On March 16, 2016, the board of directors of United Airlines, Inc. (*United*) adopted resolutions appointing Mr. Munoz United s principal executive officer effective March 14, 2016 and stating that, effective March 14, 2016, Mr. Hart will no longer be United s principal executive officer.
