## Oil Discovery in Sergipe State

---

(Rio de Janeiro, March 11, 2003). PETROLEO BRASILEIRO S.A. Petrobras, (BOVESPA: PETR3 / PETR4, NYSE: PBR / PBRA, LATIBEX: XPBR / XPBRA), Brazil's largest oil and gas, petrochemicals and energy company, announces that, according to existing legislation, Petrobras informed the National Petroleum Agency ANP on March 10, 2003 that it had found indications of the existence of oil in two recently drilled wells off the coast of Sergipe.

In fact, until now two wells have been drilled, the first, 1-SES-147, when tested produced an average 3,000 barrels per day. On March 10, 2003 a second well was completed in an adjacent structure, when the information was submitted to the ANP, informing the occurrence of a hydro-carbon holding reservoir.

Petrobras continues its surveys and evaluation operations so as to determine the economic feasibility of these hydro-carbon accumulations that, if these findings are positive, will be considered as oil fields.

Before the conclusion of these evaluations, Petrobras cannot arrive at any conclusions concerning volumes of the find that at the present moment must be considered of a speculative nature.
