- (4) By a trust created by me on December 15, 2006 (the "2006 Three Year Trust") of which I am the income beneficiary. I am the trustee of this trust. I do not have the power to revoke this trust. On November 7, 2007 11,769 shares were transferred from the 2006 Three Year Trust to the 1991 Trust.
- (5) On November 15, 2007 the remaining 33,966 shares held by the 2004 Three Year Trust were transferred to a trust created by me on March 31, 1999 (the "1999 Gift Trust") for the benefit of an adult son of mine who does reside with me (see note 10). I am a co-trustee of this trust. I do not have the power to revoke this trust.
- (6) I disclaim beneficial ownership of the 10,131,559 shares held by a partnership, a general partner of which is a trust for the benefit of my sister which she has the power to revoke and of which I am a co-trustee (Reported pursuant to Rule 16a-8(b)(2)).
