- (1) The reporting person acquired variable rate convertible unsecured subordinated notes with a face value of \$44,000 at a price of \$21,340 (48.5% of face value). The notes mature on June 15, 2013 and have a variable interest rate equal to 6-month LIBOR plus 0.375%. Holders of these notes may convert all or some of their notes into shares of ADC common stock at any time prior to maturity at a conversion price of \$28.091 per share.
