## Explanation of Responses:

  - (1) The Google Stock Units ("GSUs") entitle the Reporting Person to receive one share of Google Inc.'s Class A Common Stock for each share underlying the GSU as the GSU vests. The GSUs vest as follows: 5/8 of the 8266 shares vest on September 25, 2013 and 1/16th of the remaining GSUs will vest on November 2, 2013 and each quarter thereafter until the units are fully vested, subject to continued employment with Google on the applicable vesting dates.
  - (2) Supplemental grant made to correct an administrative error in the calculation and issuance of the original equity award granted on February 2, 2011.
 

The GSUs entitle the Reporting Person to receive one share of Google Inc.'s Class A Common Stock for each share underlying the GSU as the GSU vests. The GSUs vest as follows: 31/48 of the 4773 shares vest on September 25, 2013 and 1/48th of the remaining GSUs will vest on October 2, 2013 and each month thereafter until the units are fully vested, subject to continued employment with Google on the applicable vesting dates.
  - (3) The GSUs vest as follows: 1/4th of the GSUs shall vest 12 months after vesting commencement date and 1/16th each quarter thereafter until the units are fully vested, subject to continued employment with Google on the applicable vesting dates.
  - (4) All shares are exercisable as of the transaction date.
  - (5) There is no expiration date for the Issuer's Class B Common Stock.
 

The option provided for vesting as follows: 25% of the option shall vest 12 months after vesting commencement date and 1/48th of shares
  - (6) shall vest each month thereafter until the option is fully vested, subject to continued employment with Google on the applicable vesting dates.
