The Compensation Committee awarded these shares, the grant of which was respectively made on February 14, 2012 and June 12, 2012, and originally reported on a Form 3 filed with the SEC on August 14, 2012, based upon performance relative to the average Return On Equity (ROE) goals during the 2012 through 2014 performance period.

(2) Represents shares withheld for the payment of taxes.

Amount reported has been adjusted to include 71 shares of Issuer common stock acquired by the reporting person under The Prudential Employee Savings Plan between June 30, 2014 and December 31, 2014 based on a plan statement dated December 31, 2014. The acquisition of such shares was exempt from Section 16 pursuant to Rules 16b-3(c) and 16a-3(f)(1)(i)(B).

(4) The performance shares convert to common stock on a 1 to 1 basis.

Represents the target number of shares to be received relative to the Company's average ROE goals for the 2015 through 2017 performance period and relative performance against certain life insurance peer companies.
