For 2016, the reporting person elected to take approximately 71% of their Board retainer in the form of shares of restricted stock with a three-year restriction period. Because the reporting person elected to take a portion of their Board retainer for 2016 in these shares of restricted stock in lieu of cash, the Company awarded them additional shares of restricted stock, equal to 60% of their Board retainer. The
