  - (1) Pursuant to Ms. Dolan's 3/12/18 employment agreement, on 3/15/18 the Company granted Ms. Dolan 69,767 restricted shares of Revlon, Inc. Class A Common Stock, par value \$0.01 per share, under the Fourth Amended and Restated Revlon, Inc. Stock Plan.
  - (1) Pursuant to Ms. Dolan's employment agreement, one-third of the restricted shares will vest in equal amounts on each of 3/15/19, 3/15/20 and 3/15/21, provided that Ms. Dolan remains employed with the Company on each applicable vesting date, subject to certain earlier vesting provisions.
