On May 8, 2006, Argan, Inc. issued to MSR I SBIC, L.P. 240,000 shares of its common stock pursuant to a certain Stock Purchase Agreement dated as of May 4, 2006. MSR I SBIC, L.P., is an entity controlled by Daniel Levinson. Accordingly, Mr. Levinson may be (1) deemed to beneficially own 786,937 shares of common stock held by MSR I SBIC, L.P. (including the 240,000 shares issued to MSR I SBIC, L.P. on May 8, 2006) as well as (i) 3,000 shares of common stock held by Tri-Lev LLC and (ii) 50,000 shares of common stock underlying warrants held by MSR Advisors, Inc.
