Mr. Ladd possesses the sole power to vote and the sole power to direct the disposition of all shares of the Company's common stock held by Laddcap.

(2) Accordingly, as of the date of this report, Mr. Ladd is deemed to beneficially own an aggregate of 2,811,839 shares of the Company's common stock. Mr. Ladd's interest in the 2,801,839 shares reported herein is limited to the extent of his pecuniary interest, if any, in Laddcap.
