Smith, Vassalluzzo and Fischer have the shared power to vote or dispose or to direct the vote or the disposal of 8,971,072, 8,971,072 and 8,574,072 shares, respectively. Voting and investment authority over investment accounts established for the benefit of certain family members and friends of Mr. Smith are subject to each beneficiary's right to terminate or otherwise direct the disposition of the investment account.
