**Item 7.01. Regulation FD Disclosure.**

On August 1, 2012, Monmouth Real Estate Investment Corporation (“MREIC”) filed a registration statement on Form S-3, covering the offering and sale of up to 3,000,000 shares of its common stock under its Dividend Reinvestment and Stock Purchase Plan (the “Plan”). As a result, MREIC is reinstating the Plan, effective immediately. As previously announced, the dividend payable to common shareholders on September 17, 2012, to shareholders of record as of the close of business on August 15, 2012 will be \$0.15 per share. MREIC generally pays dividends to common shareholders quarterly on the 15<sup>th</sup> day of March, June, September and December, and does not currently intend to make any changes to its dividend rate.
