- (1) There is no reportable change since the last filing. This is a reiteration of holdings only.
  - (2) Each restricted stock unit represents a contingent right to receive one share of HP common stock.  
As previously reported, on 04/20/12 the reporting person was granted 11,220 restricted stock units ("RSUs"), all of which cliff vested on 04/20/13. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities beneficially owned immediately prior to the transaction being reported includes 73.0296 dividend equivalent rights at \$20.28 per RSU credited to the reporting person's account on 07/05/12; 99.3320 dividend equivalent rights at \$14.91 per RSU credited to the reporting person's account on 10/03/12; 98.6045 dividend equivalent rights at \$15.02 per RSU credited to the reporting person's account on 01/02/13; and 67.5965 dividend equivalent rights at \$21.91 per RSU credited to the reporting person's account on 04/03/13. These RSUs cliff vested on 04/20/13, at which time the vested shares were delivered to the reporting person.
  - (4) The number of derivative securities in column 5 includes 339 vested dividend equivalent rights and a de minimus adjustment of 0.4374 due to fractional rounding of the dividend equivalent rights.
