(the Reporting Person) a conditional warrant to purchase from the Company up to 5,441,116 Ordinary Shares of the Company, nominal value NIS 0.03, subject to the terms and conditions set forth below, effective as of June 27, 2004. This warrant may be exercised only in the event that the Company does not comply with its obligation to repay certain loans to Bank Hapoalim BM & Bank Hapoalim exercised a guarantee provided by the Reporting Person. Moreover, this warrant shall expire upon and be void as of October 10, 2007, subject to the full repayment of the loans and full release of the guarantees.
